



**ELEMENTARY/MIDDLE SCHOOL SUMMER PROGRAMS
PARENT COMMITMENT FORM 2018**

I (We) understand and agree:

1. That it is a privilege to attend Milpitas Christian School and therefore will uphold the School with a positive attitude and our prayers. We agree to share any complaints only with the appropriate School staff and not with child(ren) or other parents.
2. That by enrolling our child(ren) we indicate our willingness to abide by the policies, procedures and rules set forth for our Preschool, Summer Academic, Day Camp, and Tutoring Programs. One summer program t-shirt is included in the day camp registration fee; additional T-shirts are \$10.00 each. A Camp T-shirt must be worn on the field trips. (T-shirts are not available for Preschool students.)
3. To uphold the School's standards of conduct and discipline; therefore, we authorize the School to employ such discipline as seems wise and expedient for our child(ren). We understand that corporal punishment is not used at the school.
4. That by enrolling our student(s) in the Summer Program(s), I/we indicate the willingness to abide by the policies, procedure and rules set forth in the Summer Programs Student/Parent Handbook. I/We will withdraw our student(s) or accept the school's right to dismiss them, if I/we become unable to support these policies, procedures and rules.
5. For Academic Summer School, there is no prorating for vacations or absences. No refunds will be given past June 1, 2018. An exception to this would be for a student who attends less than one week of summer school and must withdraw because of a family emergency (an explanation of the emergency is required in writing). Students may be withdrawn from the programs for lack of payment.
6. For MCS Day Camp, to follow the reservation deadlines with the understanding that any cancellation to a reservation must be made 14 days prior to the week of camp. Modifications to your reservation can be made at any time. There is no credit for absences. Payment will be made electronically via Electronic Fund Transfers on one of the three dates that MCS offers. Families may be withdrawn from the programs for lack of payment.
7. To pay late pick up fees of \$5.00 for the first 15 minutes (6:30-6:45 p.m. at the Elementary Campus, and 6:00-6:15 p.m. at the preschool campus) and then \$2.00 per minute thereafter for each additional minute.
8. To sign my child in and out daily. If the child is to be picked up by someone other than those listed on the emergency form, we require written permission from the child's parents to be given to the daycare staff. It is the parent's and/or authorized adult's responsibility to sign each child in and out of the program. (When children transfer from the Summer Academic Program to Day Camp, the daycare staff will sign them in). For safety and security, any child who is not picked up from the Summer Academic Program within 15 minutes after dismissal will be taken to the school office. A fee of \$5.00 (per occurrence) may be charged to parents who fail to sign their children in or out on a regular basis.
9. To give permission for my child(ren) to go on all field trips during his or her participation in the Summer Program, both Academic Summer School (which runs from June 18 to July 16, 2018) and Day Camp, (which runs from June 11 to August 10, 2018). During these times my child will abide by the Summer Program policies for discipline, such as "time-outs" and privileges revoked. I release the team leaders, teachers, directors, and school from all liability and waive any claims against them. All MCS students are covered by an accident policy, whether at school or on a field trip. I authorize MCS staff to apply the sunscreen I supply for my child, when needed.
10. Binding Arbitration Agreement: If any dispute arises from the enrollment of this student, I/we agree to follow a three-step process to resolve the dispute. The dispute will be brought to the superintendent, the board of directors and last to binding arbitration, as designed by Peacemaker Ministries. I/We understand that I/we are expressly waiving our right to submit any dispute to a court of law. Copies of the Peacemaker Ministries guidelines are available in the Business Office.
