If a child is to be picked up by an adult who is not listed on their emergency form, we require written permission from the child's parent(s)/custodial adult to be given to the extended care staff. It is the parent's and/or authorized adult's responsibility to sign each child in or out of the extended care program. (Extended care staff will sign children in to after school care.)
